THE ON DEMAND SUBSCRIPTION INCLUDED ACCESS TO 8 NEWLY-PRODUCED CHORAL PROGRAMS FEATURING OUR 32-MEMBER PROFESSIONAL ENSEMBLE SINGERS, OUR 120-VOICE VOLUNTEER CHORUS, OUR 30-MEMBER YOUTH CHOIR (VESOTA), GUEST ARTISTS REPRESENTING CULTURALLY DIVERSE PERSPECTIVES, AND PROFESSIONAL ORCHESTRAL MUSICIANS, ALL LED BY THE VOCALLESSENCE ARTISTIC STAFF. THE PROGRAMS WERE VIDEO-RECORDED AT UNIQUE VENUES AROUND THE TWIN CITIES AND PRODUCED FOR LATER PREMIERE TO VOCALLESSENCE ON DEMAND SUBSCRIBERS. VOCALLESSENCE SOLD 691 ON DEMAND SUBSCRIPTIONS AND 481 SINGLE-CONCERT STREAMS. A TOTAL ESTIMATED 5,000 PEOPLE VIEWED THE VOCALLESSENCE ON DEMAND SERIES, WHICH
